1.	<p><b>LICENSE FEE</b></p> <ul style="list-style-type: none"> <li>- Free Zone beneficiary pays for the License Fee for the first five years of operating in the Free Zone of Port of Bar (until reaching the total amount of 10,000 euros), and after this period the License fee becomes valid for an unlimited period of time;</li> <li>- If the user pays the entire License Fee (for the first five years of operating in the Free Zone) during the first year of operating in the Free Zone, the user achieves a discount of 20%.</li> <li>- After payment of the entire amount of the fee, the License for performing activities in the Free Zone of Port of Bar becomes valid for an unlimited period of time.</li> <li>- If it is a program (a new job related to the basic port activity, goods distribution center, production program, ...) that has a significant positive impact on the expected development of activities in the Free Zone, increment of volume of transshipment through Port of Bar, increment in employment, ..., the Board of Directors of “Port of Bar” JSC may decide to provide the License fee free of charge for the Free Zone beneficiary.</li> <li>- License for performing activities in the Free Zone is transferable - License for performing activities in the Free Zone can be (once) transferred from one beneficiary to another Free Zone beneficiary.</li> </ul>
2.	<p><b>FEE OF APROVAL OF “TRIAL PERIOD” ***)</b></p> <ul style="list-style-type: none"> <li>- Fee refers to the requests for performing activities in the Free Zone for a period of three (3) months;</li> <li>- The “trial period” for performing activities in the Free Zone can only be approved once to the same Free Zone beneficiary, which must be followed by signing a Contract for performing activities in the Free Zone;</li> </ul>
3.	<p><b>FEE FOR USING THE PORT INFORMATION SYSTEM FOR CUSTOMS RECORD KEEPING</b></p> <ul style="list-style-type: none"> <li>- Beneficiary may choose to keep Customs records through its own storage service or using the Port Information System;</li> </ul>
